

Notice Inviting Expression of Interest (EOI)

Standby Electric Supply for STP and Pump House

DAV University, Sarmastpur, Jalandhar (Punjab), plans to provide modern/latest standby electric supply for STP and Pump House, in the premises of the University comprising of automatic gen-set of capacity 300 to 350 kVA with environment friendly features on turnkey basis. Presently the University has 3 centralized Gen Sets of capacity 250kVA-1 No. & 160 kVA – 2 Nos, one 500 kVA and one 63 kVA gen sets. A change over system is also required by way of electrical panel between existing 250kVA gen set and 160 kVA gen-set.

EOI must be submitted to the undersigned on prescribed Format (**Annexure I**).

EOI should Include:

1. Detailed Specification of the Product with manuals and costing sheet
2. Detailed specification of cables and accessories etc. to be installed with manuals and costing sheet
3. Detailed installation/Labour charges
4. Standing of the firm showing details of the clients served by the firm.
5. Warranty/guarantee clause clearly specified
6. Availability of Service Centre in the proximity of the DAVU
7. Silent operation parameters.
