**Observations and Action Taken**  
**2018-19**

Observations:


1. The academic and administrative audit was conducted on the basis of fifteen parameters.
2. It was observed that most of the faculty have maintained attendance registers.
3. Most of the departments have conducted BOS meetings.
4. Relatively few departments organized expert lectures, conferences, seminars and workshops.
5. Most of the faculty members conducted quizzes and assignments on time.
6. Most of the faculty members published research articles.

Action taken:

1. The coordinators of the departments were requested to improve the frequency of national and international conferences.
2. The coordinators were also requested to conduct more expert lectures, seminars and workshops for faculty and students.
3. The coordinators were informed to arrange remedial classes for underperforming students.
4. The coordinators were requested to improve the number of publications in their respective departments.
