




1. B.A.LL.B (Hons) Five year Integrated Course 2024 onwards.







The proposed Schemes were discussed at length and resolved to incorporate the following changes as under:

Decision: The Board approved the course schemes and all the syllabi of the courses emphasizing on the following points:


1. The course scheme and syllabus of **LL.M** in Criminal and security law was discussed in detail and was approved as presented with changes (New Guidelines have been added in Term Paper LLM511).
Changes Proposed:
In the Subject of Police Law and Administration the Police Act, 2007 has been Introduced with new guidelines of the Hon'ble Supreme Court Guidelines.
2. The course scheme and syllabus of **P.hD** in Law was discussed in detail and was approved as presented.
3. The course scheme and syllabus of **BBA LLB** was discussed in detail and was approved as presented.
4. There were minor changes in syllabi of following subjects in course BA LLB Hons have been done as per new guidelines.
 - a. BAL151, BAL251, BAL351, BAL451, BAL551, BAL651 (Political Science)
 - b. Due to amendment in criminal laws old IPC has been replaced with Bhartiya Nyaya sanhita 2023. (New syllabus has been added)
 - c. Due to amendment in criminal laws old CRPC has been replaced with Bhartiya Nagarik Suraksha sanhita 2023. (New syllabus has been added). Also the Addition of the Comparison topic with Old Criminal Procedure Code, 1973 and the new Bhartiya Nagarik Suraksha sanhita 2023.
 - d. Due to amendment in criminal laws old Law of evidence has been replaced with Bhartiya Sakshya adhiniyam 2023. (New syllabus has been added).
5. As per the suggestions of experts, in BA.LLB (Hons) for the overall enhancement of the students in the field of Law, Liberal Electives will be added in 9th semester
6. There were minor changes in the syllabi of BAL804 Land Laws including RERA.
Meeting ended with thanks to all participating members.


