






Report of Committee regarding Grievance of [redacted] student of  
UG Degree Programme in Journalism and Mass Communication




The concerned faculty member [redacted] was called in the office of Registrar to inquire about the matter and the student [redacted] was contacted through virtual WhatsApp meet as she hails from the remote area of Kashmir and due to financial constraints could not appear in person.

The committee is to submit that [redacted] had submitted the assignment virtually through WhatsApp within the deadline but showed her inability to submit the hard copy of the same even after repeated reminders by the concerned faculty member within the deadline of uploading of marks on DAVIS portal. Considering it as a special case, the committee recommends that the concerned faculty may be allowed to evaluate and assign the marks in the concerned course after initiating the process of rectification.


Further, the committee do not appreciate the remarks of "negligence of teacher" in the grievance of the student. The student was advised to refrain from making such remarks.



Observation Report

On the basis of the complaint filed by the complainant and after considering the statements given by the class representatives and eye witnesses, it has been observed that there exists a notable lack of mutual understanding and coordination between the teacher and the students. The following directives and recommendations are made to address the issue:

- The complainant is directed to maintain due respect towards the teachers. Any doubts or concerns, whether from the complainant or any other student, should be addressed while maintaining respect towards the teachers.
- It is imperative for the teacher to ensure clarity in concepts asked by the students. Additionally, separate classes for doubt-clearing sessions will be conducted daily until the End Semester Examination to facilitate better understanding among students.
- A request is made to the department coordinator to ensure that mutual coordination prevails between teachers and students. Any discrepancies observed in this regard should be promptly reported to the Office of the Dean Students' Welfare for further action.

It is hoped that these measures will foster a more harmonious and conducive learning environment for all parties involved.
