

## Internal Complaint Committee

This committee has been constituted so that any student can report to the university about any sexual harassment or physical abuse, including, domestic violence, dating violence or stalking whether committed by an employee, student, or member of the public, occurring on DAV University property in connection with all the academic, educational, extracurricular, athletic, and other programs of DAV University, whether those programs take place in DAV University's facilities or at another location, or on and off-campus site or facility maintained by DAV University, or on grounds or facilities maintained by a student organization, is a violation of DAV University's policies and regulations, and is subject to all applicable punishment, including criminal procedures and employee or student discipline procedures.

Step2: The complaint will be directed/forwarded to the ICC committee.

Step3: The ICC committee will conduct an investigation as per UGC (Prevention, Prohibition and Redressal of Sexual Harassment of women employees and students in Higher Education Institutions) Regulation, 2015.

#### OFFLINE MODE:

Step1: The student can submit the written complaint in the office of the Dean Student welfare or any member of the committee.

Step2: The complaint will be directed/forwarded to the ICC committee.

Step3: The ICC committee will conduct an investigation as per UGC (Prevention, Prohibition and Redressal of Sexual Harassment of women employees and students in Higher Education Institutions) Regulation, 2015.


